Alejandra presented on updates to education services and the impacts of education due to COVID-19.

Discussion:

Q: (Teri House): Were there any homeless liaisons laid off due to budgetary shortfalls?

A: (Alejandra): Yes, West Contra Costa, Mt. Diablo and Antioch all had changes. Antioch lost the homeless liaison. The previous foster liaison will now carry out both responsibilities. Mt. Diablo also had a change in liaison and has tentatively identified an individual. West Contra Costa has Julie Loretta who previously focused on serving families in transition will be supporting foster and homelessness. There will be pressure on caregivers and service providers to advocate because there will only be one liaison. Alejandra noted there will be access to education whether it be distance learning or in person and this will bring changes in needs including school supplies and transportation.

Q: (Leslie via chat): Regarding school meals, are there any changes in how this will happen, or it will be the same as at the end of last year and over the summer?

A (Alejandra): Depends on the district. This can vary. Alejandra can provide updates on specific districts.

Hotel Program Data

Jamie Klinger provided overview of the Hotel Program Data. Lavonna Martin clarified there are 599 rooms for persons under investigation (PUI).

Highlights Include:

- Number of rooms procured for PUI/COVID positive and high-risk consumers and utilization rates. (Slide 24)
- Average length of stay, Number of consumers who have exited the program and the top exit destinations. (Slide 25)

Discussion:

Q:(Maureen Nelson via chat): I heard Winter Nights Shelter is being cancelled. Is Project Roomkey going to serve these people?

A: (Lavonna Martin): To her knowledge, Winter Nights Shelter is not cancelled, but they are considering starting the program later in the fall. Winter Nights was provided guidance and will be modifying the program accordingly. Judith can speak to this at some point.

Proposed CES Hotel Prioritization

Lavonna Martin introduced the strategy developed in January, so the system of care can work towards this as we move forward in the context of COVID-19. Lavonna reviewed goals and the four strategies that will be used to meet the goals. Erica McWhorter introduced the CES Hotel Prioritization for permanent housing. Shelby Ferguson presented the recommended prioritization plan that was approved through the Oversight Committee on July 30, 2020.

Discussion:

Q (Tony Ucciferri): Is there a timeframe for all of this in the way of a waiver or is this a permanent plan?

A (Shelby and Erica): It is not a permanent change. There is no period of time determined for this prioritization, but likely will be used for the entire length of time the hotel program is in place. Tony wanted to make sure that HUD was on board with this plan.

Leslie also pointed out that the group reviewed a redlined version that was sent out to the group in the meeting. An updated version was sent after the meeting and this was sent to the COH for review and approval. Leslie asked if the version the COH had was the most updated version as there were edits provided.
 - Erica explained there were edits made to the document that the COH received for approval.

- Leslie detailed concerns about voting without seeing the final language and was unsure if the document and written policy the COH was asked to approve would be a part of the Project Homekey application.
- Erica noted we could vote on the version the COH received prior to the meeting.
- Doug Leich asked if the COH was able to vote on a specific version of the policy because it wasn't shared ahead of time and clarified that the motion was to approve the description of the prioritization process.
- Lavonna Martin responded by stating they were approving the current prioritization process not just the policies and procedures. There would be an opportunity to review the policies and procedures and add in the comments and edits at a later time.

Project Homekey NOFA

Lavonna Martin provided an overview of the Project Homekey NOFA and announced that Contra Costa County submitted an application, the fifth application submitted in the state.

Highlights include:

- NOFA Overview including amount, project types, target population and tiering (Slide 32)
- Contra Costa County will be competing with eight other Bay Area Communities for \$91 million.
- Overview of the Contra Costa County Application. (Slide 33)
- Application includes a Coordinated Exit strategy. (Slide 34 and 35)
- Erica McWhorter described key components in the coordinated exit strategy.

Discussion:

Q (Jonathan Russell via chat): In terms of actual PSH availability, is the pacing/flow of openings still roughly 36 per year? Considering this, how might the newly approved prioritization plan affect (if at all) the existing queue of those awaiting PSH vis a vis the (re)prioritization of the clients in exiting hotels?

A: (Lavonna Martin): We never had enough resources to begin with and at the end of the day there is no change in the number of individuals who need the service nor has the availability for supportive housing in PSH changed. The flow will continue to be the same. The hotels will open up interim housing ability and create additional flow. As we look to continue to bring on PSH, we have a HUMS project, but we need to continue to build PSH. Lavonna referred to the strategy described earlier in the meeting to detail how this would fall into that strategy.

Q (Jill Ray via chat): What is the percent of homeless who need permanent supportive housing (PSH) in our County?

A (Erica): There is a high need for PSH in Contra Costa that has not gone away with the addition of the hotel program. HUD and other funders have been making it clear that building PSH is not the most rapid or effective option. We are looking to include alternatives. In addition, there are enough PSH to meet about 50% of the need per year with an additional 2900 more permanent housing interventions needed to meet needs including PSH.

Q (Leslie via chat): So glad to hear about expand housing navigation what funds will we use for this, and how will providers be identified?

A (Lavonna): Hope Solutions is the housing navigation provider and has been successful at gaining additional funding through Contra Costa Regional Health Foundation to support housing navigation services through hotels. There has been additional funding through Kaiser which is coming soon. The system is still working to bring in additional resources. These are good questions to bring and discuss at the COVID Meeting series.

Q (Tony): Is the letter of support still needed if the application is already submitted?

A (Lavonna): The process has been a little backwards. The state encouraged applicants to submit enough so the state can get applicants in queue and they will request the additional necessary documents. This letter will be provided at that time. The funds need to be expended by December so there was a need to expedite the process.
