GONSALVES & SANTUCCI (Applicants and Owners) - CENTRAL CONTRA COSTA SANITARY DISTRICT (Owners), County File #SD17-9459: The applicant requests approval of a tentative map to subdivide a 66.57-acre portion (comprised of two parcels) of the 95-acre project site into six individual industrial lots. The project site is a 95-acre area comprised of five parcels located along the western boundary of the Walnut Creek Channel, approximately 0.74 miles south of the Waterfront Road bridge/crossing, in the unincorporated Martinez area.
