

Iron Horse Corridor (IHC) Management Program Advisory Committee Meeting Notice and Agenda

DIRECTIONS: From I-680 south, take Exit 47 (North Main Street) and follow North Main Street south to Arroyo Way. Arroyo Way is a left turn after Fuddrucker's. Follow Arroyo Way east to North Broadway and then make a right on North Broadway. Follow North Broadway south to the Walnut Creek Library, 1644 North Broadway, which is on the left. Turn left into Lincoln Avenue, and the parking for the library will be on the left.

From I-680 north, take Exit 44 to exit at Rudgear Road. The exit ramp becomes South Broadway. Follow South Broadway through Walnut Creek to Mt. Diablo Boulevard. Here South Broadway becomes North Broadway. Continue on North Broadway to Lincoln Avenue. Make a right turn into Lincoln Avenue, and the parking for the library will be on the left.
