CBOs could present and discuss more on their challenges that came out of the pandemic. If were looking for more money for these agencies then we should show it's an effective program. We wanted to look beyond Contra Costa County and see how other counties are developing their programs. Could we partner with a different county? Can participants cross counties?
 - Michelle: We don't need to recreate the survey. Would like to have additional questions that speak to disability access for individuals that have disabilities. Could be more concise. Would like to take a qualitative approach to this.
