

# PROPERTY TAX DEFAULT (DELINQUENT) LIST

Made pursuant to Section 3371, Revenue and Taxation Code

I, WILLIAM J. POLLACEK, Contra Costa County Tax Collector, State of California, certify that: Notice is hereby given that the real properties listed below were declared to be in tax default at 12:01 a.m. on July 1, 2005, by operation of law. The declaration of default was due to non-payment of the total amount due for the taxes, assessments and other charges levied in 2004-2005 that were a lien on the listed real property. **The name of the assessee and the total of these and subsequent delinquent taxes, assessments and other charges that are due as of September 1, 2008, are shown opposite the parcel number.** Tax-defaulted real property may be redeemed by payment of all unpaid taxes and assessments together with the additional penalties and fees, as prescribed by law, or it may be redeemed under an installment plan of redemption. If the taxes remain unpaid after July 1, 2010, the property will be subject to sale at public auction.

## PARCEL NUMBERING SYSTEM EXPLANATION

The Assessor's Parcel Number, when used to describe property in the list refers to the Assessor's map book, the map page, the block on the map, if applicable, and the individual parcel number on the map page or within the block. For example, parcel number, "003-360-009" would mean Book 3 of the Assessor's maps, Map Page 36 and Parcel 9 on that map. For example, parcel number "003-363-005" would mean Book 3, Block 363 (Map 36, Block 3) and Parcel 5 within that block. For example, parcel number "003-360-700" or "003-360-799" would mean Mineral Rights in Assessor's Map 36, in which parcel numbers 700 through 799 indicate Mineral Rights only. Parcel Maps are available for inspection in the Office of the Assessor.
