

BUILDING INSPECTION REQUIREMENTS

The following criteria are used by the Building Inspection Division to determine whether temporary and permanent power pole permits can be issued:

- 1. **Temporary Power Poles:** Temporary power pole permits are issued only in conjunction with a building permit. Temporary power pole permits are for construction purposes only and are not to be issued for use with wells, mobile homes, docks, etc.
- 2. **Permanent Power Poles:** A specified use for the power pole must be stated.

When a power pole permit is issued for a well drawing either agricultural or potable water, the applicant must show proof that a well permit has been issued by Contra Costa County Environmental Health Division (925-692-2500).

Permanent power pole permits may be issued on lots without a residential unit for supplying power to boat docks, which must be illuminated pursuant to County Municipal Code Section 76-2.1012, which requires .02 foot candles provided for the dock. These poles shall be limited in ampacity to allow connected load. Boat docks shall have one (1) power outlet of a locking and grounding type, rated not less than 20 amperes per slip. A 15 amp rated circuit is allowed for dock lighting. There shall be no other outlets allowed. Please see National Electric Code, Article 555 for additional requirements regarding boat docks.
