The Public Works Director will receive sealed bids at the Public Works Department, 255 Glacier Drive, Martinez, California 94553-4897, until 2 o'clock p.m., on April 7, 2020, at which time they will be publicly opened and read, for: 2019 On-Call Contract(s) for Various Road, Flood Control, and Airport Maintenance Work.

General work description: The work consists of various road, flood control, and airport maintenance work to provide support as needed to Public Works Maintenance crews for various routine road, flood control, and airport maintenance repairs, such as, but not limited to, pavement repairs and replacement, crack seal, slurry seal, skin patching, asphalt concrete cold planing, pavement leveling, shoulder widening, hot mix asphalt paving, storm damage repair work, rock slope protection, slope stabilization, culvert repair work, and concrete structure repair work.

Maximum on-call contract amount: \$900,000 for a one-year period with the option of two one-year extensions.

The County, in sole discretion, may award one, two, three, or four \$900,000 on-call contracts to the first, second, third, or fourth lowest responsible bidder(s) as applicable. Each bidder may be awarded only one on-call contract.

The Contractor's attention is directed to Section 10-1.02, "Order of Work" and Attachment A, "Scope of Work," in the special provisions. Prospective bidders shall be located within driving distance and 50 miles from 2475 Waterbird Way, Martinez, CA 94553.

The bidder is required to subcontract a minimum of 10% of its bid in accordance with the Mandatory Subcontracting Minimum requirements within these special provisions.

A pre-bid meeting will be held on Monday, March 23, 2020 at 10:00 a.m. at the Public Works Department to cover project construction and the County's Bidder Outreach Program. Prospective bidders attendance is recommended but not mandatory.

Contract Documents, including specifications, may be viewed **but not obtained** at the Public Works Department, 255 Glacier Drive, Martinez, California 94553-4897, Monday - Thursday (7:00 a.m. - 5:00 p.m.), and Friday (7:00 a.m. - noon and 1:00 - 4:00 p.m.). The specifications can be obtained via the Contra Costa County Public Works Department's Online Planroom at [www.cccounty.us/pwprojects](http://www.cccounty.us/pwprojects). A non-refundable service charge for bid documents is required in the amount of \$25.00 (sales tax included). Shipping charges are extra, depending on the delivery method. The Public Works Department does not guarantee the arrival of the specifications in time for bidding. You may obtain electronic PDF copies of the specifications upon purchase of the bid package through the Online Planroom at no additional cost.

This project is to be advertised pursuant to Public Contract Code 22037.

This contract is subject to state contract nondiscrimination and compliance requirements pursuant to Government Code, Section 12990.

The Contractor must possess a valid Class A or Class C-8 or C-12 License at the time the Contract is awarded.

Prior to submitting a bid, the Contractor and subcontractors must be registered with the Department of Industrial Relations and qualified to perform public work pursuant to Labor Code section 1725.5, subject to limited legal exceptions under Labor Code section 1771.1.

This contract will be subject to compliance monitoring and enforcement by the Department of Industrial Relations pursuant to Labor Code section 1771.4.

Bids must cover the entire project, and neither partial nor contingent bids will be considered.

The successful bidder must furnish a payment bond and a performance bond.

The Board has ascertained the general prevailing rate of wages applicable to this work. The prevailing rate of per diem wages is on file with the Clerk of the Board of Supervisors, and is incorporated herein by reference thereto, the same as if set forth in full herein. For any classification not included in the list, the minimum wage will be the general prevailing rate for Contra Costa County.

All bidder questions/inquiries received before 12:00 p.m. the Thursday prior to the scheduled bid opening will be posted with their responses on the Public Works Web Site ([www.cccounty.us/pwprojects](http://www.cccounty.us/pwprojects)). Questions received after this deadline will remain unanswered. The current planholders list can also be found at this website.
