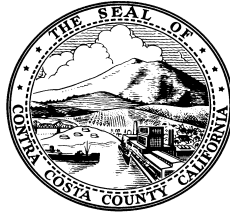

FILING INSTRUCTIONS

REQUIRED MATERIALS:

1. **APPLICATION:** One completed copy of this Application Form.
2. **FILING FEE:** \$5,000.00. Check made payable to "Contra Costa County Department of Conservation and Development."
3. **COPY OF NOTICE OF NONRENEWAL:** One copy of the completed Notice of Nonrenewal, which is required to be completed prior to requesting a Cancellation.
4. **COPY OF LAND CONSERVATION CONTRACT:** One copy of the Land Conservation Contract requested for Cancellation.
5. **MAP COPIES:** One copy (8.5"x11" or 11"x17") of ASSESSOR'S MAP PAGE(S) specifying all properties or acreage to be included in the Cancellation. The Assessor's Map Page may be obtained from the Assessor's Public Records section.
6. Any additional information that demonstrates or otherwise substantiates the statutory findings required for Cancellation. This may include recent soils testing, analysis of water quality, crop yield information for the past six (6) years, or any other relevant information.
